



# 2017 NJFA MEMBERSHIP APPLICATION

The most important issues facing New Jersey woodland owners are Farmland Assessment and ensuring they can meet the changing program requirements. Farmland Assessment is under constant attack by people and politicians who do not understand the vital contributions made by private landowners. The requirements have changed many times since the Farmland Assessment Act was originally passed in 1964—and more changes are proposed every year.

The New Jersey Forestry Association (NJFA) monitors legislation and regulations affecting Farmland Assessment and actively works on behalf of private woodland owners. This year, the NJ State Forest Service, working in conjunction with the Division of Taxation, has released proposed Forest Stewardship regulations that could have a dramatic impact on how many woodland owners manage their properties. The NJFA has provided testimony in support of the new regulations and will continue to provide updates to its members. Are you familiar with the proposed regulations? Could you keep your property without Farmland Assessment?

The NJFA was founded in 1975 to support the very special and unique needs of private woodland owners in New Jersey. NJFA offers meetings, seminars, and field tours to assist land owners in achieving the goals they have set to manage their properties. We publish a quarterly newsletter on the latest happenings in the forestry world and partner with other organizations such as the NJ State Forest Service, SAF, Tree Farm, Rutgers and NRCS, to make sure our members have the tools they need to meet their goals.

We ask that you become a member, or renew your membership, so we can continue to protect New Jersey's forests and maintain the programs that allow woodland owners to be great forest stewards. Membership dues are minimal but the benefits are priceless.
